Director's Report:

- 1. Loretta submitted the FY 2026 PNG grant application to the Illinois State Library, requesting \$28,914.
- 2. The new Library Services Coordinator and a new Library Assistant started on August 18. Both are working out well after two weeks on the job.
- 3. There are plans to revive the book bike for outreach. The new Library Services Coordinator will take the bike to the September and October Third Thursdays on the square and the MHS homecoming parade.
- 4. Loretta is preparing detailed notes for the new director as well as cleaning and organizing files.

Committee Reports:

- 1. **Personnel:** There were two new hires: Library Services Coordinator and Library Assistant for main floor.
- 2. Building and Grounds: Nothing
- 3. Finance: Nothing
- 4. **Friends:** Carolyn reported the book sale and ongoing book sale totals came to \$1,440. The Friends also voted to donate to the nonresident library card reimbursement fund again this year—enough to fund an estimated 60 households. The Friends will also be offering "Friends Bucks" as an incentive for book sales.
- 5. **Technology:** The library will phase out Hoopla for audiobooks and e-books. The cost of Hoopla has become unsustainable. Libby by OverDrive will be the substitute for Hoopla at a 30% savings. Hoopla is estimated to continue through November while Libby will be available in September.

1. The Director Search Committee consists of Andrea Bradley, Jenna Griffith, and Matt Colboth. The ad was published today, 9/8/25.

New Business:
